# 1819/158 Resident letter received following the Town Council's decision to object to a planning application for Retail Development at Low Prudhoe

The Council gave due consideration to the previously circulated email correspondence received from a Prudhoe resident dated 6<sup>th</sup> December and 14<sup>th</sup> December 2018 **it was AGREED** that the Town Clerk should respond to the resident explaining the context of the Council's decision, as set out in the press release issued by the Town Council reaffirming that the council's decision to object to the application was on a very fine majority decision; reiterating that the Town Council shared her concerns and wanted to see the sustainable development of Prudhoe's retail offer reminding Mrs Palmer that Prudhoe Town Council are not the Planning Authority so the decision on the planning application does not rest with the Town Council.

## 1819/159 Funding for Detached Youth Service via Prudhoe Youth Initiative (PYI)

Consideration was given to the tabled report of the Prudhoe Youth Initiative setting out proposals for commissioning a detached youth service for 12 months from April 2019, following discussion on this item and the benefit of the Town Council's financially supported 2018 Summer Holiday programme it was AGREED that the Town Council would reaffirm their funding of £8000 for this financial year 2018/19 and that the Council agreed in principle to support the project with the proviso that the Council's funding of the project from the 2019/20 budget would need to be made at the Extra Ordinary Budget Meeting that will take place on 23rd January 2019.

#### 1819/160 Television Licence Refund Scheme (TVLS)

Members gave consideration to the previously circulated report of the Town Clerk and the related email correspondence from Karbon Homes Customer Relationship Manager and taking into account their responsibilities under s137 of the Local Government Act 1972; that further changes are required to the administration of the scheme in view that Karbon Homes are no longer able to support the council, and following matters raised by the council's external auditor; that the council should ensure that all those entitled are aware of the scheme, and should budget accordingly, currently all those entitled to the £30 grant do not claim it, based on the last published census the cost would be £32,850 although currently only £12,000 is budgeted and the fact that in June 2020 the Government will cease to fund the free TV Licence for the over 75's and the decision as to whether it continues will be taken by the BBC, (and it is as is probable that the BBC will not continue this), there is likely to be a subsequent increase in the number of claimants to the Prudhoe Town Council refund scheme, it was AGREED to cease the TV

Licence Refund Scheme at the end of this financial year. In making their decision Councillors were mindful that if better publicised the scheme could result in a far greater expenditure than the council had ever committed to the scheme and therefore a bigger burden on the council tax payers of Prudhoe. Councillors were concerned about the impact on those in real need of discontinuing the scheme, but in view that it is not means-tested were accepting that there was no way of establishing this.
