Gemma Nixon, Youth Project Manager: -

Gemma reported that the Project has delivered a busy and successful quarter, marked by increased participation across multiple groups, the introduction of an effective BACS payment system, and the distribution of a parent/carer survey to support service evaluation.

A wide range of activities has been delivered across all youth groups, including creative, recreational, and educational sessions. These have supported young people's social development, wellbeing, and life skills, with opportunities to explore important topics such as relationships, online safety, and discrimination in a safe and supportive environment. Attendance has grown in several groups, with new members joining and engagement levels increasing.

Targeted support has expanded significantly, with a notable rise in one-to-one provision, now supporting eight young people through referrals from schools and partner services. School drop-in sessions continue to be well attended, providing guidance on education pathways and personal development.

Community-based provision remains active, with ongoing sessions in West Wylam and the development of provision in Mickley, which is currently under review to maximise engagement.

Planning is progressing well for upcoming programmes and events, including the Easter holiday activities, a residential trip, and the Water Safety Day in July, which will involve multi-agency partnership working and community engagement.

Myself and the Clerk met with Russ, Greg, and Sam Talbot to discuss this year's Miners Race and an update on other initiatives.

I also attended the Borderlands meeting where updates on current initiatives were provided.

The "Prudhoe Goes Green" event, held yesterday, was well attended and demonstrated strong community engagement in environmental initiatives.

It was noted Councillors were advised that a further Borderlands update would be provided at the next meeting, with representatives from Prudhoe Community Partnership and Northumberland County Council scheduled to attend the April Ordinary Meeting. Councillors were therefore asked to reserve any questions for that session.

SLCC Conference

The Deputy Clerk and I attended the SLCC (Society of Local Council Clerks) regional training seminar in Newcastle on Wednesday 11th March 2026. The seminar was an all-day event covering a comprehensive range of topics, including AGAR, banking hubs, and other relevant governance and administrative matters. The training provided valuable updates and guidance as well as networking opportunities to support our work.

English Heritage

Attended meeting held on Wednesday 18th March 2026, during which discussions took place regarding working in partnership with English Heritage to raise the profile of the castle and to deliver a programme of events throughout the year.

Prudhoe Goes Green

Attended meeting held 25th March 2026, updates were provided on upcoming and ongoing initiatives, including the Climate Round Table event with MP Joe Morris, proposals for 'Orange' planting in support of domestic abuse awareness, and progress relating to Prudhoe in Bloom.

Further discussion covered updates on new Council environmental contracts and service areas, alongside progress reports on a range of green space projects, including the Wildlife Garden, Bee Bed, Ladybird Bed, Pocket Park, The Glade, Edgewell Cemetery, Waterworld, Fire Station Beds, and Prudhoe Walled Garden.

An update was also received on the Prudhoe Land Use Survey, as well as plans for the upcoming Eco/Recycling Fair. Members noted arrangements for the Scarecrow Festival, scheduled to take place from 13 April to 23 May, and received an update regarding the Repair Shop/Café initiative.

c) County Cllrs Reports

County Cllr Lawrence O'Donnell (Prudhoe North & Wylam)

- I attended the library consultation at Prudhoe Library, there was a good turnout, and strong support. I will be continuing to urge people to take part in the consultation and would urge Prudhoe Town Councillors to do the same.
- I met with green spaces officers, parking services and Highways at the Tyne Countryside River Park to discuss alleviating problems with café customers unable to park due to the car park effectively being used as a commuter overflow. A good solution will hopefully be implemented soon.
- Environmental services have written to homeowners on a street in Castlefields to urge them to park more considerately to allow the wagons unobstructed access on bin collection days.
- The Police have also spoken to the owners of vans parked on Castlefields Drive causing a dangerous obstruction.
- Double yellow lines will be extended on Duke's Way from Princess Way to allow HGV access to businesses. I have asked Advance Northumberland to redesign the parking on the other side of Duke's Way to add parking spaces and ensure that there is extra parking available for those that currently park where the double yellow lines will be painted. They are arranging for their team to review the proposal and report back.
- I met with Openworks in Low Prudhoe which has rapidly expanded and is now employing 91 members of staff.
- I attended the Cash access UK consultation in Ginevra on Front Street and learnt how businesses will be able to register for the extra services available to them.
